

T IS OUITE SAD THAT VARIOUS HEALTH STATISTICS SHOW THAT DESPITE THE INTRODUCTION OF WEST-ERN/BIOMEDICAL/ORTHODOX HEALTHCARE SYSTEMS THROUGH BUREAUCRATISATION, WITH EMERGENCE OF HOSPITALS IN THE EARLY PART OF 20Th century the overall health status of our people HAS DECLINED, SINCE THE IMPACT OF HEALTH IS ITS OVERALL EFFECT ON THE HEALTH STATUS AND SOCIO-ECONOMIC DEVELOPMENT OF THE NATION AND PEOPLE. There is need to ask ourselves how, why and when did we descend to this level? Indeed, the nation's infant/maternal mortality rate is on the increase. Life expectancy, that is the number of years to live in good health remains low. Why are we being projected as a nation of unhealthy people with no contribution to world progress and development now or in the past, particularly socio-culturally and economically?

According to historical facts, on the arrival of the colonialists and missionaries to our continent and missionaries on our continent they met able bodied, good spirited men

and women of good health. Millions of our people were taken away as slaves on long journeys through land and sea with little or no food and water, no health facilities for months, were able to survive the ordeal and were able to work long hours on farms and state camps to assist in the development of the western world. This evidently shows that at any particular time in most cultures the people have ways and means of taking care of their health needs. In order for us to be able to answer the question earlier raised, there is need to understand health and the concept of traditional medicine.

What is Health?

Health is defined by World Health Organization (WHO) as a complete state of physical, social, mental and spiritual well being and not mere absence of disease. Health like other aspects of human life cannot be adequately or wholly understood outside the context of the total human environment, the social and cultural components of which are equal if not greater than physical.

What is Traditional Medicine?

Traditional medicine is defined by WHO (1976) as the sum total of all knowledge and practices whether explicable or not used in diagnoses, prevention and elimination of physical, mental, social and spiritual imbalance, relying exclusively on practical experience and observation handed down from generation to generation, whether verbally or in writing.

From these it is quite obvious that failure to meet our basic health care need has been due to the orientation of our care planners towards a particular approach to health care, which put emphasis on the treatment of the sick in hospitals or individual general

practice.

Understanding the inadequacies of the current curative oriented health care, WHO adopted Primary Health Care as a philosophical commitment and strategy to meet the challenge of Health for All by 2000" in Alma Ata 1978.

The Alma Ata declaration in 1978 specifically stated that mobilization of traditional healing systems is the way to make health for all a reality.

WHO further explained that traditional medicine includes diverse health practices, approaches, knowledge and beliefs incorporating plant and/or mineral based medicine, spiritual therapies, manual techniques and exercises applied singularly or in combination to maintain well-being as well as to treat, diagnose or prevent illness.

As of the year 2000 WHO reported that 25 countries reported having a national policy on traditional medicine. Despite the Alma Ata declaration and the relevant recommendation of WHO governing bodies and orientation of Regional Health for All policy for the 21st century, which underscores the importance of traditional medicine and its practitioners in primary health care.

I will like to use this opportunity to express appreciation for the pragmatic approach of the Hon. Minister for Health in putting together the National Traditional Medicine and Draft Policy/Bill and thanking him for his efforts in inviting WHO regional adviser on traditional medicine Dr. Ossy Kasilo, WHO expert committees led by Prof. Abayomi Sofowora, collaborating agencies and a broad range of partners with diverse interests in traditional medicine to partake in the draft policy bill.

In the past years we have witnessed increased government interest in the development of our traditional medicine in with the establishment of the Nigeria Natural Medicine Development Agency (NNMDA) under the Federal Ministry of Science and Technology and the drafting of the National Traditional Medicine Policy and Bill.

In Lagos State the health reform bill includes recognition of traditional medicine in Primary health care and drafting of the law regulating the code of conduct of practice and practitioners. I believe with the passing of the bills, our traditional medicine will assist in developing specific regulatory capacity especially for herbal medicine and define their role in National Health Care Delivery System, just like the observation by WHO that populations throughout Africa, Asia and Latin America use traditional medicine to help meet their primary health care needs due to its accessibility, affordability, acceptability and availability via sustainability.

It is also often part of a wider belief system and meanwhile in Australia, Europe and North America complementary and alternative medicine is increasingly used parallel to allopathic medicine particularly for treating/managing chronic disease.

The growing use of traditional medicine has created public health challenges in terms of policy, safety efficacy and quality, access and rational use.

At present due to processes powered by societies, increased individualism of farming, under employment and demands for cash economy; professionalism has been giving way to commercialism. There has been a growing concentration of fraudulent practitioners offering services to the general public as traditional, spiritual and alternative medical practitioners who have not undergone any specific training and perhaps unlikely to be under any organisation and prey on the misfortune of people with ill health.

It is my belief that the passage of the bill and policy will enable us to implement WHO's working traditional medicine strategy for 2002 – 2005 which to my opinion is flexible enough to integrate with our needs because it addresses the following issue National policy; safety.

The strategy provides a framework for action for WHO and its partners to enable traditional medicine to play a greater role in reducing excess mortality and morbidity especially among the impoverished population.

The strategies are:-

Safety, efficacy and quality

- Establish registration and licensing of providers.
- Establish national regulation and registration of herbal medicines.
- Establish safety monitoring of herbal medicines and other TM (Traditional Medicine) therapies.
- Provide selective support for clinical research into use of TM for treating the country's common health problems.
- Develop national standards, technical guidelines and meth-

- odology for evaluating safety, efficacy and quality of TM
- Develop national pharmacopoeia and monographs of medicinal plants.

Access

- Identify safe and effective TM therapies and products. larly for poorer populations.
- Recognize role of TM providers in providing health care.
- Optimise and upgrade the skills of TM providers
- Protect TM knowledge through recording and preservation.
- Cultivate and conserve medicinal plants to ensure their sustainable use.

Rational use

- Develop training guidelines for country's most commonly used TM therapies.
- Strengthen and increase organization of TM providers.
- Strengthen cooperation between TM providers and other health care providers.

Conclusion

With the passage of the bill, careful planning and collaboration among different levels of the health sector, a partnership can be built which in response to public demand, creates a pluralistic health care environment based on quality in health care and on the provision of services which complement one another. This will enable us embark on advocacy for community orientation, dissemination of appropriate information, promotion of the attitudes and practice, and also discontinuing of harmful practices. Also, this will promote job and wealth creation through the herbal industry.

It is my sincere belief that by following the advice of Chairman Mao Tse Tung during the Chinese cultural revolution in 1947 when he said "To surrender to old style is wrong, to abolish or discard is wrong, our responsibility is to unite those old styles that can be used and help stimulate them" we will keep the hope and dream of Elizabeth Kafaru alive.

"We are Reaching, Touching and Changing Lives!"

> omeone once said and I quote, "There is no greater joy than the joy of giving". Indeed there is really no greater joy for me than giving. There is a special joy one derives in every act of giving to the right cause, even the holy books affirm this. I am of the opinion that giving should be inherent in man's nature and hence come naturally.

> My appetite and thirst for giving have seen me take up responsibilities that are outside my obligations as a lawmaker in the past four years that I have represented my constituents. I ensured I always set aside part of my statutory income to give back to my constituency as there is no such provision as constituency allowance at the Lagos State House of Assembly as some have alleged. Out of these funds I provided potable water in the eleven wards in my constituency and I recently sank two additional boreholes in two riverine communities.

In all the 36 primary schools in my constituency I supplied free note books to all pupils in my "Books for all Initiative", this was a follow up to the secondary school programme which had come up earlier. sponsored free dental healthcare delivery in the form of a mobile dental clinic that went around my constituency with many who would otherwise not find it convenient visiting the dentist taking advantage of the gesture in all wards in my constituency. In August 2014, I held a constituency empowerment programme tagged, "Eleniyan Mega Empowerment Programme" at Pobo community primary school, Poka. At the event I supported 640 artisans from numerous associations and walks of life with craft and trade tools, Cash gifts were handed out to the elderly at the event to support their upkeep, this was however not the first time I had done such. Items such as sewing machines, vulcanizer machines, grinding machines, hair-driers, deep freezers, popcorn machines, fumigating machines, carpenter tools, bricklaying tools and bicycles for farmers were handed out to the tradesmen and artisans. Early this year I

sponsored a free eye screening test, free reading glasses distribution and surgery which I tagged "JIGI ELENIYAN", we had over a thousand people, young and old in attendance at both centres. No fewer than 78 persons had surgeries carried out them.

I am currently paying the salaries of teachers in some of our primary and secondary schools, the school's head-teachers and I had to employ this strategy as a result of the acute shortage of teachers in those schools, this is in addition to over a hundred of students in higher institutions of learning across the country and those seeking entrance into higher institution whom I have at one time assisted and still assist in the payment of schools fees

and examination fees. I have also facilitated provision of electrical transformers in quite a number of communities within my constituency, while assisting financially with their installation and I have gone as far as purchasing poles and cables in the rural areas where these have not been present. With the restoration of electricity to parts of Epe, many communities realized that the electrical installations in their domain had been vandalized, in no time my table was full with requests for assistance. Clearly this was not one of my responsibilities, but the onus however fell on me as I cannot ignore the suffering of my people. Consequently, I took the burden of providing the funds for purchasing the equipment and repairs.



Hence it did not come to many as a surprise when on the 31st of May, 2015 the children of Sir Michael and Doja Otedola commemorated the first year anniversary of their father's death with a health fair programme tagged "2015 Sir Michael Otedola Health Fair: Epe Medical Mission", taking a cue from their father's love for humanitarian service and how he loved to be remembered. The event which took place in a hall constructed by Sir Otedola for the community of Odorangunshin, Eredo LCDA Epe where he hails from and Epe General Hospital where surgical operations were carried out, had in attendance over 40 Medical Practitioners flown in from Canada, Russia, USA and their Nigerian counterparts offering free, topnotch, medical services such as surgical operations, dental care, pediatrics clinic, diabetes diagnosis; blood sugar, cholesterol and blood pressure checks as well as other preventive healthcare services sponsored by the family.

The event witnessed a large turnout of both the young and old from our communities and neighbouring towns that swamped the venue having heard about the event on radio to take full advantage of the kind gesture of the Otedola Family. This was a first of its kind in Epe and there are plans to expand its reach beyond Epe to other part of Lagos according to the family as a means of reliving the legacies and philanthropy of their father Sir Michael Otedola..

Agriculture as a Potent Antidote to Unemployment

he highlights of the unemployment watch for the first quarter of 2015 by the National Bureau of Statistics (NBS) states that a total of 17.7 million people between the ages of 15 and 65 are either unemployed or underemployed in the labour force in first guarter of 2015, debatable as this figures seems what is clear is that there is an harmony of thoughts among stakeholders and in the country that the unemployment rate in Nigeria requires the most urgent attention given the protracted high rate. In the quest to reduce the upward trend of unemployment one sector we essentially have to turn to is that of agriculture. This sector has unarguably been neglected far more than any others in our economy since the discovery of crude oil in spite of its vast potential. With the high rate of unemployment and apparent scarcity of jobs in the formal sector (it is worthy of note that lure of white collar jobs has also been largely responsible for the lack of interest in agriculture by our educated youth) and the seeming food insecurity occasioned by the continued rise in prices of food items due to the decline in production; there has never been a time better than the present for our youth and indeed our nation to redirect resources and energy to agriculture where we have a comparative advantage with our vast fertile land, favourable climate and human capital.

The agricultural sector, if appropriately harnessed, has the capacity to put a lot of unemployed youth, graduates to work thereby considerably reducing the unemployment rate in the country and can also contribute immensely to the country's gross domestic product. To achieve these objectives, a significant amount of financial investment will however be required as well as technical support from the government and other

agricultural support agencies particularly in the provision of heavy farm machinery and expertise locally; the right government policies and enabling environment devoid of the typical surface scratching and lip services policies we have witnessed in times past and an attitudinal change in our youth who have apparently developed apathy towards agribusiness. Regrettably many in our nation have become so accustomed to imported food over time to the detriment of our economy and personal life. A look at our import portfolio reflects how deeply dependent we are as a country; according to statistics, more than 75% of consumable food items and their raw materials are imported; chicken, fish, turkey, beef, rice, fruits and vegetables, confectionaries, beverages, the list goes on and on. The south west of Nigeria for example is richly endowed

with fertile, arable, soil and climatic conditions capable of growing crop all year round. Ironically, this region depends majorly on food crops such as tomatoes, pepper, watermelons, yams, potatoes etc. shipped in from the northern parts of the country despite the unfavourable climatic condition for crop production in the north. AN EVIDENCE OF GOD'S INVOLVEMENT

t has been widely acknowledged that what is grossly lacking in present day political institutions in Nigeria is the connection between the leaders and the governed. Access to political office holders by the people has become a mirage over time. As we look forward to a system that is constantly advancing upwardly, we equally anticipate a legislature which is all about the people.

The truism that "one good turn surely deserves another" proved its efficacy in what turned out to be an exclusively "peoples matter" in Epe constituency II in the last general election when the people overwhelmingly returned their current representative in person of Hon Segun Olulade .

THE PRE-ELECTION SCENARIO

The first major hurdle before Hon Olulade was picking the party's ticket to become flag bearer of the All Progressives' Congress (APC) in the general election. Would Olulade return for a second term? What about the tradition of rotation between the two major LCDAs (Ikosi-Ejinrin & Eredo) that formed Epe II? Would the peoples' love for

Olulade's efficient representation break the jinx of power shift? On Saturday the 2nd of December 2014 the journey to the 8th Assembly began with the primary election among contenders in the party. No one had ever represented Epe Constituency II for two consecutive terms. 337 votes dangled before the 3 Aspirants (Segun Olulade, Tunde Agbabiaka and Afolabi Onasanya) as party delegates stepped out in orderly manner to cast their votes under the supervision and monitoring of state electoral

officers deployed from Eti-Osa local government area. However, worthy of note is the fact that, prior to voting one of the aspirants (Afolabi Onasanya) stepped out and announced that, he was stepping down for Hon. Segun Olulade and that, all his delegates should cast their votes for him.

In an election that has been adjudged free, fair and credible by aspirants and delegates, the chief presiding officer took to stage at exactly 1:10pm to pronounce the winner in a simple majority of the total votes cast. Unambiguously, out of the 337 total votes, Hon Segun Olulade polled a whopping 266 votes, while his opponent Tunde Agbabiaka polled just 66 votes and 5 votes were voided due to irregularity in the voting patterns of 5 delegates. The ovation was loud; the margin was clear, with exactly 200 votes ahead of his opponent; the victory was overwhelming, the atmosphere was agog with celebration and applause. The APC in Epe II had finally elected the party's flag-bearer who would slug it out with candidates from other parties in the general election in the race to the 8th Assembly. Segun Olulade broke the jinx to become the first honourable member to return as party flag-bearer to the House back to back in Ene II

The decision to support Olulade to represent Epe II for another term was popular among party leaders and the teeming membership. The reason is not far-fetched; Hon. Election held at Fredo

Prior to election time, a passionate and detailed Olulade staged two major exercises tagged "WALK FOR PROGRESS" across the two major LCDAs that formed Epe II: Ikosi-Ejinrin and Eredo, to kick start his campaign for the general election. The walk was a political awareness exercise that recorded over 4,000 participants in the two outings. The high point of it was the moment 83 year old great grandmother and wife of former governor of Lagos State (HE. Sir Micheal Otedola), Mrs. Doja Otedola, joined the Eredo Walk



at Odo-Iragunshin and walked unaided with the team to Eredo LCDA as an inspiration. The walk was described as the first of its kind in the history of Epe constituencies at large. The build up to the general election saw an Olulade that ran a campaign like a crusade. Even at the instance of anticipated victory at the general election, he left no stone unturned. His belief in the people triggered a house to house campaign that went on for weeks throughout the 11 wards in his constituency. 



I should also use this medium to advise and educate our numerous constituents that it is time we did away with the entitlement mentality whereby we over-burden the Legislators with mundane requests borne out of the fact that you have supported or helped them to win elections. While I agree that the Legislators have the moral responsibility to assist their constituents within their means, constituents should not overstretch their requests to the extent that Legislators would be afraid or discouraged to run their constituency offices with utmost efficiency or even run away from their constituency. A situation where a constituent wants to marry a 3rd wife and the person to bear the cost of his love escapades is his Legislator is detestable, or when naming ceremonies or remembrance party for the deceased is considered the responsibility of the Legislator.

For the purpose of information, out of the 40 Members-elect we have 32 from the All Progress Congress (APC) and 8 from the People's Democratic Party (PDP). Also, amongst the 40 are 4 females in all. 3 are from the APC and 1 from the PDP. However, I am glad to inform you that ever since we have been having meetings and interactions with these politicians, it has been in harmony and friendliness. This disposition is highly encouraging and commendable and Lagosians should look out for a vibrant Assembly that would serve the well-being of the good people of the State.

A lesson in uprightness and staying true to ones conviction.

he history of any country cannot be complete without mentioning the men and women who have led the country at one time or the other. In Nigeria, since our independence we have experienced a shared mix of civilian and military leaders intermittently, among these leaders stand out two men who have been privileged to govern us as both military heads of state and democratically elected presidents. These two men are President Olusegun Obasanjo and President Muhammadu Buhari. The circumstances surrounding the emergence of these two former military heads of state who were generals in the military as democratically elected presidents is an interesting one to digest. President Obasanjo returned from prison to become president, while President Buhari contested for four consecutive times before winning. Both leaders have set an enviable record and will always be a reference point without any doubt; President Buhari's chapter however makes a more interesting discourse for his seemly uprightness and conviction which provides an inspiration to all.

President Buhari was born on the 17th of December 1942, in Daura, Katsina State to his father Adamu and mother Zulaihat. He is the twenty-third child of his father and was raised by his mother after his father died while he was still a boy. In 1971 he married his first wife, Safinatu (née Yusuf) Buhari, they had five children together, four girls and a boy, In 1988, he and his first wife Safinatu were divorced and in December 1989, he married his second and current wife Aisha (née Halilu) Buhari. They also have five children together, a boy and four girls.

He was military head of state from the 31st of December, 1983 to the 27th of August 1985, when he was toppled in a coup d'état by General Ibrahim Babangida. Prior to this he had held quite a number of important positions of government; he was a one-time federal commissioner (position now

around the country. In 2003, he ran for office in the presidential election as the candidate of the All Nigerian People's Party and was defeated by the People's Democratic Party nominee, General Olusegun Obasanjo. He was nominated as the consensus candidate of the All Nigeria People's Party in the 2007 polls losing to Umaru Yar'Adua of the People's Democratic Party, After President Yar'Adua assumed office, the ANPP agreed to join his government but he (Buhari) denounced this agreement. He would later run unsuccessfully again in the 2011 elections also losing to Goodluck Ebele Jonathan of the People's Democratic Party, until 2014 when he emerged as the presidential candidate of the All Progressives Congress for the 2015 general elections; thereafter defeating the incumbent President Goodluck Ebele Jonathan. President Buhari's story has been that of conviction; staying true to his beliefs even when the odds were against him, his never say die attitude and uprightness are evident in his political voyage. Those who have ever contested in any election can testify as to how tasking and exhausting the process can be, it then takes an individual with very a strong conviction to contest for the office of president not one but four consecutive times the manner President Buhari did, losing three times in a row and still have the tenacity to continue. This trait is uncommon in modern history and its worthy of admiration and emulation. The just concluded 2015 general election on its own was also a test of President Buhari's uprightness; in the primaries that saw him emerge as his

The Mosunmola Olulade's Views CHILD MARRIAGE

A Menace To Nigeria's ocial-Economic Growth

he Child rights act passed in 2003 increased the minimum age of marriage to 18 for girls. According to statistics nationwide, 20 percent of girls are married by age 15, and 40 percent were married by age 18. Child marriage is extremely prevalent in some regions. In the northern region of Nigeria, 48 percent of girls were married by age 15, and 78 percent were married by 18; 27 percent of married girls aged 15 to 19 are in

polygamous marriages. In the southern part of Nigeria, girls are morprone to pregnancy outside wedlock. Child marriage is a formal or informal marriage union entered into by an individual before reaching the age of 18 years as in the case of Nigeria through some cultural traditions.

Child marriage has lasting consequences on girls from their health, education and social development perspectives, these consequences last beyond adolescence. One of the most common causes of death for girls aged 15 to 19 in Nigeria is pregnancy and child birth. Though Islamic marriage practice has been said to permit marrying of girls below age 10, parents should know that doing such could and will endanger the health and education of their female children. These girls are most likely to be infected with HIV, or sexually transmitted diseases as a result of being married to sexually active old men. Pregnant girls aged 15 to 19 are twice likely to die in child birth, while women in their 20s, and girls under the age of 15 are five to seven times more likely to die during child birth which is due to physical immaturity of the pelvis and because their birth canals are not fully developed at this tender age. Teen pregnancy particularly below the age of 15 increases the risk of developing Obstetric Fistula. Child marriage affects the life of the offspring and also comes with the possibility of having pre-term or low birth weight babies. Infant mortality rates are 60 percent higher and infants born tend to have weaker immune systems and face a high risk of malnutrition as it can be seen in the majority of children born in the Northern region. Death or divorce of the girl child spouse can cause intense hardship on them since most of them have little or no education and training. This is a vicious cycle that affects the economy of the country. A widowed or divorced woman with kids and no form of education or training would likely bring up kids with little or no care thereby making them constitute a nuisance to the system.

Domestic violence and non-consensual sexual intercourse against the girl child is more likely to occur because of their ages. Some husbands and family might have high expectation from these girls who are also children and they are often faced with severe and life threatening marital violence and can lead to depression and suicidal thoughts. In my view, girl child marriage has been promoted as a result of poverty, gender inequality, insecurity, traditions and culture. Girl child marriage is an infringement on a woman's rights to equality on grounds of sex and age, to receive the highest attainable standard of health, freedom from slavery, access to education, freedom of movement, and freedom from violence, reproductive rights, and rights to consensual marriage. The consequence of these violations not only affects the woman, but her children and the society at large United Nations Human Right Council recognizes child marriage as a human rights violation and thus plans to eliminate child marriage. Wasila Umar, a 14yr old child bride in April killed her husband and four of his friends through food poisoning. If nothing is done, it is clear that Nigeria and other countries where child marriage is prevalent will continue to fall short in their efforts to improve the education, health and well-being of millions of its citizens. In Nigeria, child marriage is a widespread practice in the Northern part of the country and it is believed that when a girl is married off early, she won't have the opportunity to become promiscuous. It is also believed that in most parts of Northern Nigeria, it is permissible for a man to marry a child as young as 9 years old, as long as he doesn't have sexual relations with her until she attains puberty. In most cases, this is not adhered to because the girl child is involved in sexual intercourse with her spouse as soon as they are married. A lot of people have disregarded the law and hide under the banner of religion to perpetuate child abuse and Nigerians must stand up to defend the rights of their children.

Girl Child marriage in my opinion is a crime against womanhood and the highest form of women slavery. If we all think this doesn't affect us in any way then we are making a great mistake. A woman is a woman whether in Nigeria or in other countries and a crime against one woman is a crime against all women. Who will fight the cause of a woman more than the women themselves? Our economy is dwindling, how do we resuscitate it without educating the girl child? Who will in turn educate her children since women are seen as the ones in charge of the home? How do you vote the right kind of leadership we need in this country when those that constitute the majority (girls/women) cannot make an informed decision of their own as a result of lack of education due to early marriage? Women must however learn to speak about their plight, needs and aspiration.
